Gray announces a public hearing by the Committee of the Whole on: Bill 18-825, the "Reverend Donald Robinson Field Designation Act of 2010;" Bill 18-859, the "Miss B's Center, the Bernice Elizabeth Fonteneau Building Designation Act of 2010;" Bill 18-965, the "Thelma Jones Way Designation Act of 2010;" and Bill 18-895, the "Bishop Glen A. Staples Way Designation Act of 2010." The public hearing is scheduled for Friday, October 22, 2010, at 10:00 a.m., in the Council Chamber, Room 500 of the John A. Wilson Building, 1350 Pennsylvania Avenue, N.W.

Bill 18-825, introduced by Councilmember Thomas, would designate the athletic field at the Edgewood Recreation Center, at 3rd and Evarts Streets, N.E., as the "Rev. Donald Robinson Field." Bill 18-859, introduced by Councilmember Graham, would name the Ward 1 Senior Wellness Center located at 3531 Georgia Avenue, N.W., as the Miss B's Center, the Bernice Elizabeth Fonteneau Building. Bill 18-895, introduced by Councilmember Barry, would (symbolically) designate the 700 block of Southern Avenue, S.E.; 800 block of Southern Avenue, S.E.; 700 block of Bonini Road, S.E.; 800 block of Chesapeake Street, S.E.; 4200 block of Barnaby Road, S.E.; and 4300 block of Barnaby Road, S.E., in Ward 8 as "Bishop Glen A. Staples Way". Bill 18-965, introduced by Councilmembers Mendelson, Alexander, Kwame Brown and Chairman Gray, would symbolically designate the alley between the 1800 block and 2100 blocks of U Place, S.E., and Good Hope Road, S.E., in Ward 7, as Thelma Jones Way.
